ORDER 06-06

WHEREAS, on the 10th day of January 2006, the Commissioners Court of Parker County, Texas, in regular meeting, considered the following matter:

Whether to prohibit or otherwise regulate hunting with bows and arrows on lots that are 10 acres or smaller and are located in the unincorporated area of the county in a subdivision.

AND having considered said matter, finds:

That prohibiting hunting with bows and arrows on lots that are 10 acres or smaller and are located in the unincorporated area of the county in a subdivision would promote public safety.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that :

Hunting with bows and arrows on lots that are 10 acres or smaller and are located in the unincorporated area of the county in a subdivision is prohibited.


Additionally, a person commits a criminal offense if the person intentionally or knowingly engages in conduct that violates this order.

It is further ORDERED that the Clerk of this Court shall place this order in the minutes of the Commissioners Court of Parker County, Texas.





SUBCHAPTER C. BOWS AND ARROWS

Sec. 235.041. SUBDIVISIONS COVERED BY SUBCHAPTER.

This subchapter applies only to a subdivision all or a part of which is located in the unincorporated area of a county and for which a plat is required to be prepared and filed under Chapter 232.

Sec. 235.042. AUTHORITY TO REGULATE. (a) To promote the public safety, the commissioners court of a county by order may prohibit or otherwise regulate hunting with bows and arrows on lots that are 10 acres or smaller and are located in the unincorporated area of the county in a subdivision.

(b) In this section, "hunting" means to hunt as defined by Section 1.101, Parks and Wildlife Code.
